IMPORTANT NOTE

Beginning 1/1/2007, the Home Builders Association is using a seasonal adjustment for its metrowide single-family home-building permit unit totals. The purpose of this change is to provide users of this report with better information regarding trends and month-to-month comparisons of building permit reports. Prior year totals in the chart above have been seasonally adjusted, and the HBA will routinely revise past data to reflect any changes in permit totals and new data. The HBA is using the X-12-Arima seasonal adjustment program used by the Census Bureau for its seasonally adjusted construction data. Monthly and year-to-date totals for individual cities and counties have not been seasonally adjusted.
