Attached you will find a list of homes entered in the Parade of Homes contests, the Pick of the Parade and Distinctive Plan & Design, which will be judged both **on Friday, September 5 and Saturday, September 6.**

Next to entry information you will see which day the home will be judged. Note that if you are entered in both contests, your home may be judged on both days. You will want to check both lists for your judging days. If your home is not listed on this sheet, it did not get entered into the contest and will not be judged.

If you need to withdraw your home from judging because it will not be completely finished, or will not be open on the parade, send a fax or e-mail to Cheryl Doria at the HBA at (816) 942-8367 or cheryl@kchba.org. Please include the builder name and entry address in the correspondence. Failure to notify the HBA in writing of an incomplete judging entry before 5pm, Wednesday, September 3 will result in a \$200 fine.

Pricing Reminder!

All winners' prices will be audited. You, as the builder, are responsible for providing us the accurate price and ensuring documentation such as MLS listings, marketing materials, etc. to support your price. If it is determined that your home price no longer qualifies for the pricing category that it was judged in, the entry will be disqualified and further penalties will be sanctioned as stated on the entry form pricing and builder agreement. Please notify the HBA about price changes in writing via e-mail at cheryl@kchba.org or fax (816) 942-8367. **Since the deadline to change prices was August 22, the HBA cannot guarantee that the home can be fit into a different price category after September 3.**

Important Info:

- Homes must be unlocked at **8 a.m. on the morning of judging and shall remain open until 6 p.m.** or until the judges have been through the home.
- There will be 2-3 judges and a host driver arriving to judge each home.
- Judges will leave a card on the counter upon departure for each contest. If your home is entered in both Pick of the Parade and Distinctive Plan & Design, you will have two completion cards. (Hopefully, they remember to do so, otherwise please leave the home open until 6 p.m.)
- Please do not call the HBA office to see if the home has been judged yet. The HBA staff does not know if the home has been judged until after all teams return to the office.
- If your home is locked when the judges arrive, they are instructed to call the HBA at which time staff will attempt to make one call to locate the builder or agent. If the home cannot be unlocked within 10 minutes of notification, it will be disqualified.
- All builders & sales staff must leave the home while judging is taking place.
- Pick of the Parade contest entries are judged in either a single family, multi-family, maintenance provided or condos & lofts category with homes of similar price. Please make sure that your home is listed under the correct category below.

- Winners will be announced at the HBA Fall Awards Ceremony, September 10 at the Downtown Kansas City Marriott Hotel. All HBA members are encouraged to attend. Call Audra Trudell at (816) 733-2220. send in your RSVP card by Friday, September 5 or register online at www.kchba.net. Tickets are \$40 per person.
- The winners will be promoted in area newspapers including the Kansas City Star's *Sunday Homes* on Sunday, Sept. 14. They will also be announced on the Parade of Homes Web site at www.kcparadeofhomes.com.

Tips:

- Make sure your home is clean. If any building material is left in the house, be sure it is neatly stacked and that the area is clean. Your garage and basement should be unlocked – **unavailable space will be counted off.**
- **All homes must have sod.** A 10 point deduction will be taken on entries without sod.
