### E. Judging

**Note: judging takes place on Thursday and Friday before start of Parade.**

**Price Categories:** Each home is assigned a price category by the Tour Committee after all contest entries have been submitted. The contest categories are not pre-set. They are determined by the number of entries submitted in those price ranges. Industry professionals from across the country are recruited especially to judge your home(s) for these competitions.

**Drivers:** If you are a Grand and/or First Runner-Up winner from the 2016 American Dream Award contest, you are required to provide a driver for this contest. Your driver can be a representative from your company or someone you do business with (banker, subcontractor).

All companies have the opportunity to volunteer a representative driver. Drivers host a team of judges (not your home's judging team), by navigating through the Kansas City area suburbs. ### ATTENTION BUILDERS!

Exact sales prices for contest entries must be upheld for the duration of the tour. If the entry's price increases during the tour, the entry will be disqualified. All prices must be honored for the two-week period.

### F. How to Determine Your Price for Judging?

#### How to determine your sales price:

The exact sales price of your entry should reflect the selling price including all options of your home the first day of judging. For model homes, the exact sales price should reflect the exact reproduction price of the home.

#### Price Documentation Deadline:

If the home is entered in MLS, builders are required to provide a copy of the listing to support price documentation. If the home is not entered in MLS or, in the case of model homes, if MLS does not reflect the reproduction price or exact sales price of the mode, please provide additional documentation. Documentation could include sales flyers or pricing lists used to market the home. Final Documentation is due

You must supply your sales price with this entry form. Revisions will be accepted if submitted in writing by **Aug 18**. NOTE: The exact sales price for the contest is separate from the sales price for the Parade of Homes Guide. Prices submitted on the parade entry form or revisions submitted during builder proofing will not be accepted as a change to the exact sales price for the contest.

***All the main living area/spaces including the master bedroom must be furnished to qualify the home and no points should be taken off, if other areas are not furnished.***

#### **Please Note Minimum Standard Rule:**

For price categories containing only one or two homes, there will be no automatic awarding for Grand Prize or First Runner Up awards. To win these awards, a home must score 90% of the average score of all the Grand Prize winners or 90% of the average score of all the First Runner Up winners. If there is not a winner we will use the same Minimum Standard Rule applied to the average scores of the homes judged by the particular team of judges.

### G. Builder Agreement

I agree to have my home 100% complete by **Sept 24** If my home will not be completed on time I will call Gina at the HBA before **Sept. 16** to withdraw from the contest. Failing to notify the HBA of a withdrawal will result in a \$200 fine.

I agree to have my home open for judging on **Thursday, September 26** from 8:00 a.m. until 6:00 p.m. and **Friday, September 27** from 8:00 a.m. to 5:00 p.m. I realize that I will be fined \$200 and my home will be disqualified if it is not accessible to the judges. The HBA will notify your company before judging as to which day your home will be judged.

I understand that I may not enter this home in a contest if it has previously won an award for that contest. (Pick of the Parade and American Dream Award are the same contest.)

I understand if I win an award this year, I am required to provide a driver as a representative of my company to drive the judges one day for the next contest -**American Dream Award**
